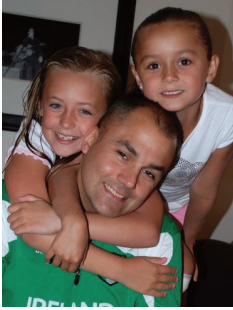


## MEET THE *CJON* ASSOCIATE EDITORS
